

ADVANCE NOTICE OF CHANGES AT HITACHI MEDICAL SYSTEMS EUROPE HOLDING AG

Hitachi Medical Systems Europe Holding AG will be undergoing a change of name (only) on or about 1 July 2021, following the acquisition by the Fujifilm group. In order to give you advance notice of this change, we would like to inform you of the following.

We are also taking this opportunity to notify you of the changes being made to the legal manufacturer of our products, the EU Importer and the EC Representative.

Whilst we have changed, the EU Importer (change to branch office of original EU Importer) and EC Representative (name change only) are staffed by the same people before and after the change of names.

Whilst the legal manufacturer is changing, the physical manufacturing site of our products in Japan will be at the same location and staffed by the same people. The legal manufacturer has been "carved out" of Hitachi, Ltd.. and the new address is the manufacturing site.

Finally, the product that has been previously offered under the brand name of Hitachi, may be delivered after 1 July 2021 under the Fujifilm brand name, however it will be EXACTLY the same product in terms of functions, specification and design. The only change is the brand and company name, which is a result of a legal change related to the acquisition by the Fujifilm group.
